

Privacy Policy

Your privacy is critically important to us. At Via Mia Camden, we have a few fundamental principles:

We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason.)

We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.

We don't store personal information on our servers or the offsite servers of the third party service providers we use to provide our core services unless required for the on-going operation of one of our services.

In our social networking and mobile application products, we aim to make it as simple as possible for you to control what visible to the public, seen by search engines, kept private, and permanently deleted.

Below is our privacy policy which incorporates these goals:

Via Mia Camden operates several websites including Via Mia Camden (collectively, the "Websites"), as well as a number of mobile applications on behalf of our customers (collectively, the "Applications"). It is Via Mia Camden, policy to respect your privacy regarding any information we may collect while operating our Websites and Applications.

Website Visitors and Application Users

Via Mia Camden, collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Via Mia Camden, ' purpose in collecting non-personally identifying information is to better understand how Via Mia Camden, ' visitors use its Websites and Applications. From time to time, Via Mia Camden, may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its Websites or Applications.

Via Mia Camden, also collects potentially personally-identifying information like Internet Protocol (IP) addresses. Such information can include location data and information of end users. Via Mia Camden, does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

Gathering of Personally-Identifying Information

Certain visitors to Via Mia Camden, Websites and users of Via Mia Camden, Applications choose to interact with Via Mia Camden, in ways that require Via Mia Camden, to gather personally-identifying information. The amount and type of information that Via Mia Camden, gathers depends on the nature

of the interaction. For example, we ask visitors who sign up for a social network at Via Mia Camden to provide a username and email address. Those who engage in transactions with Via Mia Camden, – are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Via Mia Camden, collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor interaction with Via Mia Camden, Via Mia Camden, does not disclose personally-identifying information other than as described below. Visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain Website-related and Application-related activities.

Aggregated Statistics

Via Mia Camden, may collect statistics about the behavior of visitors to its Websites and users of its Applications. For instance, Via Mia Camden, may monitor the most popular social networks on the Via Mia Camden site. Via Mia Camden, may display this information publicly or provide it to others. However, Via Mia Camden, does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Via Mia Camden, discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Via Mia Camden, behalf or to provide services available at Via Mia Camden, Websites and Applications, and (ii) that have agreed not to disclose it to others. For instance, Via Mia Camden uses third party vendors and hosting partners to provide the necessary hardware, software, networking, data storage, and related technology required to run the services available at Via Mia Camden, Websites, and Applications. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Via Mia Camden, Websites and Applications, you consent to the transfer of such information to them. Via Mia Camden, will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Via Mia Camden, discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when Via Mia Camden, believes in good faith that disclosure is reasonably necessary to protect the property or rights of Via Mia Camden, , third parties or the public at large. If you are a registered user of an Via Mia Camden, Websites or Applications and have supplied your email address, Via Mia Camden, may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what going on with Via Mia Camden, and our products. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Via Mia Camden, takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor computer, and that the visitor browser provides to the website each time the visitor returns. Via Mia Camden, uses cookies to help Via Mia Camden, identify and track visitors, their usage of the Via Mia Camden, Websites, and their website access preferences. Via Mia Camden, visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Via Mia Camden, Websites, with the drawback that certain features of Via Mia Camden, Websites may not function properly without the aid of cookies.

Ads

Ads appearing on any of our Websites or Applications may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Via Mia Camden, and does not cover the use of cookies by any advertisers.

Privacy Policy Changes

Although most changes are likely to be minor, Via Mia Camden, may change its Privacy Policy from time to time, and in Via Mia Camden, ' sole discretion. Via Mia Camden, encourages visitors to frequently check this page for any changes to its Privacy Policy. If you have a Via Mia Camden account, you should also check your social network dashboard for alerts to these changes. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.
